



VISA FOR UNIVERSITY STUDIES

Warning: The Consulate General reserves the right to request further documentation or guarantees if deemed necessary for evaluating the application. The documentation indicated below must be submitted as follows:

- In the order indicated in the list.
- All provided documents must be apostilled.
- All documents in Arabic must be translated into Italian by a sworn translator.
- The entire application file must be photocopied.

1	☐	Visa application form, original: Duly completed and signed by the applicants in the designated spaces (in the signature box indicated on the 3rd page). Applied consular fee: 50 €.
2	☐	One passport photo: Compliant with ICAO standards, must be glued to the application form.
3	☐	Passport, original: An ordinary passport valid for at least three months beyond the duration of the requested visa.
4	☐	Passport, photocopy: 1 Photocopy of the passport pages containing biographical data and identity, including a photocopy of the pages containing validity extensions, any annotations, and the pages containing previously obtained Schengen visas, as well as all entry and exit stamps from the Schengen Area.
5	☐	Pre-enrollment summary: Summary of the pre-enrollment application for a university course on the UNIVERSITALY portal, validated without reservation (or with reservation limited to cases of language tests and admission tests yet to be carried out).
6	☐	Proof of financial means: Equal to not less than € 10,179.85 annually for the duration of the academic year. - The availability must come from lawful and traceable sources, and the presentation of cash is not allowed. - It must be proven by an irrevocable bank restriction. - To this amount must be added the availability of the sum necessary for repatriation (can also be proven by showing a return ticket). - Economic means can be: personal or family means (up to the 4th degree); financial guarantees provided by Italian institutions and credit institutions, local governments, or foreign institutions and bodies deemed reliable by the Italian diplomatic mission, or Italian or foreign citizens legally residing in the State territory. - The nominal value of the bank account balance at the time of the visa request, which could derive from a "one-off" or "ad hoc" deposit, is not exhaustive, but must be accompanied by a broader assessment of the socioeconomic situation of the applicant and their family unit.
7	☐	Financial Support: - Written declaration from parents or a family member within the 4th degree, translated and apostilled, with the commitment to financially support the student for the entire duration of the study period in Italy. - Family status of the persons cohabiting in the family unit or certificate of kinship if the family member is not cohabiting. - Demonstrable family income via payslip or pension, and bank statements of the last 6 months of the beneficiaries. - In the case of a non-parent guarantor, a written declaration must be presented, translated and apostilled, with the commitment to financially support the student for the entire duration of the study period in Italy. Furthermore, the guarantor must present adequate documentation to justify the provision of € 10,179.85 in favor of the student: family status, payslips and bank statements for the last 6 months, tax return, accommodation, etc.. - In the case of a guarantor who is a foreign citizen legally residing in Italy or an Italian citizen, the following documents must be provided (in addition to the written declaration, with the commitment to financially support the student for the entire duration of the study period in Italy): certificate of residence, copy of Italian passport or identity card, copy of residence permit, family status, payslips and bank statements for the last 6 months, tax return, accommodation.



8	☐	Accommodation: Availability of adequate accommodation in Italy: valid hotel reservation for an initial period of at least 30 days, or a rental contract already stipulated, declaration of hospitality, or assignment of confirmed accommodation at a university residence.
9	☐	Insurance: Insurance with national bodies or companies, or a foreign insurance policy with a declaration of coverage for urgent medical expenses without limits or exceptions.
10	☐	Travel: Travel reservation.
11	☐	Educational qualification Based on the chosen course of study, the student will present: 1. <i>for Bachelor's Degree/first-level academic Diploma courses and for single-cycle courses:</i> a) original final qualification of secondary studies, obtained with at least 12 years of schooling; the final qualification must alternatively be accompanied by: • an attestation of comparability and an attestation of verification of authenticity issued by the Italian ENIC-NARIC center (CIMEA); • Declaration of Value of the foreign educational qualification, if the CIMEA attestation does not explicitly state that the authenticity of the presented qualification has been verified; b) certificate attesting the passing of academic eligibility tests, possibly required for access to the University of the respective countries of origin; c) certified true Italian translations of the documents indicated in points a) and b); d) any other documentation referring to the verification of the truthfulness of the foreign educational qualification; 2. <i>for Master's Degree/second-level academic Diploma courses and, more generally, for second and third-cycle courses:</i> a) original educational qualification corresponding to the 1st or 2nd cycle of the Bologna Process (EQF Level 6 or 7), based on the course to be accessed; obtained at an official higher education institution; the qualification must guarantee, in the country where it was issued (locally), access to the next academic level (2nd or 3rd Bologna cycle / EQF Level 7 or 8); evaluated without finding substantial differences compared to the Italian system, in compliance with the Lisbon Convention and the methodology of the Italian ENIC-NARIC center (CIMEA). The final qualification must alternatively be accompanied by: • statement of comparability and statement of verification of authenticity issued by the Italian ENIC-NARIC center (CIMEA); • Declaration of Value of the foreign educational qualification, if the CIMEA attestation does not explicitly state that the authenticity of the presented qualification has been verified; b) certificate issued by the competent Higher Education Institution attesting the exams passed, as well as, for each discipline, the detailed programs for obtaining the aforementioned qualifications. c) any certified true Italian translations of the documents; d) any other documentation referring to the verification of the truthfulness of the foreign educational qualification.
12	☐	Language certification The Institutions independently verify linguistic competence by organizing a test before the visa request. The University uploads the evaluation result in the pre-enrollment application to exempt the Diplomatic Missions from this verification. The minimum level required is B2 for Bachelor's, Master's, and single-cycle courses; B1 for Foundation Courses. If the test is not organized by the University, the only valid certifications for obtaining the visa, which must be at least B2 level, are those issued exclusively by the Italian Cultural Institutes or by schools of the CLIQ circuit (Certificazione Lingua Italiana di Qualità): University for Foreigners of Perugia, University for Foreigners of Siena, Roma Tre University, and the Dante Alighieri Society.
